POWDER X RAY DIFFRACTOMETER

Basic powder x-ray diffractometer fully software controlled with the following speCifications.

A. Basic unit

1. X-RAY GENERATOR:

- i. Maximum output power : 3.0kW
- ii. Maximum Voltage : 60kV
- iii. Maximum Anode Current : 80mA
- iv. Minimum voltage and current steps: lkV and lmA
- v. Stability <0.01% at 10% power fluctuation.
- vi. Control Fully controlled through software

2. X-RAY TUBE:

Cu-tube with ceramic insulation with line focus and point focus facilities. The arrangement should be such that the tube can be rotated from line to point focus without disconnecting the water utilities and without realignment. Cu tube power: 2.2 kW.

- 3. **GONIOMETER:** The goniometer with 9-9 geometry. The goniometer should have the following features
 - i) Scan speed 0.001 -1.250/sec or better
 - ii) Measurable 20 range :0.5 -160° or better (The vendors are requested to provide Ag-Behante or any other reference sample with data showing the low angle (<1°) performance.)
 - iii) Minimum step size: 0.0001 ° or better
 - iv) Angular reproducibility : <u>+0.0001°</u> or better
 - v) Angular accuracy :<u>+</u>0.0025° or better
 - vi) Slew speed : 12° / sec or better.

There should be provision for both transmission and reflection geometries with sample position horizontal. The mounting and demounting of other accessories should not require any realignment of the goniometer.

4. OPTICS:

- i. Fixed and programmable variable slits with symmetric and asymmetric illumination and other utilities required to facilitate low angle measurements as specified above.
- ii. Primary monochromator for rietveld refinement should be quoted for mounting in the incident beam side preferably with no loss of intensity.
- iii. Focusing mirror geometry is preferred to increase the flux at the sample.
- iv. Secondary monochromator should be quoted for mounting on the diffracted beam side to avoid fluorescence.
- v. Ni-filter to get pure Cu-Ka. line.

5. DETECTOR:

- i) A state of the art solid-state detector with no requirements for gas filling and constant recalibration.
- ii) Detector must be capable to work in both scanning and fixed modes.
- iii) It should work both in zero and one-dimension modes.
- iv) It should have a high resolution, lower dead time, and higher precession
- v) It should be capable of working with a secondary monochromator.

6. LOW TEMPERATURE ATTACHMENT:

- a) Close cycle refrigerator to achieve temperature range from 10 K to +310 K or wider preferably with automatic height compensation.
- b) Temperature stability: < 0.1 K
- c) This should include all accessories like compressor, temperature controller, other control units, vacuum system, connecting hoses, sample holders etc.
- 7. High temperature attachment which can go upto 1200 C.
- 8. ICDD PDF4 database with 3-user license for at least 5-years of free updates.
- 9. SAMPLE HOLDERS: Standard sample holders (10 numbers), zero background sample holders to deal with small powder samples (3 numbers) and Silicon or any other high resolution reference sample.
- 10.An Indian make chiller of adequate capacity for the XRD should be quoted.
- 11.COMPUTER CONTROL: A 21 inch desk top and window based PC should be provided for all operations of the XRD with latest configuration (500 GB hard drive, 4GB RAM, 1-7 processor). A LaserJet color printer should also be provided.

12. SOFTWARE:

- i) The software should be capable of simultaneous diffractometer control, data collection and analysis, peak search, search-match, profile fitting and elaborate pattern treatment such as data smoothening, background subtraction, $k\alpha 2$ stripping, etc.
- ii) Software for profile analysis (Rietveld refinement), abinitio structure solution, quantitative phase analysis, estimation of lattice constants etc should be part of the basic unit.
- iii) All software should be provided with minimum of 5 user licenses to be loaded on separate PCs.
- 13. Warranty -Minimum 3 years warranty should be provided for a continuous operation of the machine.
- B. **OPTIONAL UPGRADABLE ACCESSORIES:** The diffractometer should have the provision to take on various attachments as outlined below and should be quoted separately
 - a) Attachments for carrying out thin film measurements, evaluation of epitaxial growth, provision for stress/strain analysis etc
 - b) Two dimensional detector with no gas filling.
 - c) Attachments for carrying out measurements on nano sized samples.
 - d) ACCESSORIES FOR POWER SUPPLY: The vendor should quote for UPS of adequate capacity to hold the power for minimum one hour including the chiller so that one can collect data for one hour without interruption.
 - e) Capillary mode data collection attachment
 - f) Multiple sample changer where more than 15 samples can be loaded at a time and the sample changer should work with the quoted reflection cum transmission sample stage.
 - g) Spare X-Ray tube (Cu)

C. CONDITIONS:

- Should confirm to Indian and international safety standards and regulations pertaining to X-ray Radiation and other hazards. Vendors to provide certificate stating the radiation dosage for the quoted model. Vendors should install and commission the machine with all the attachments and demonstrate all applications as specified above.
- Users should be given training at our site.
- The vendor has to stand guarantee for the relocation of XRD machine once the permanent campus of IISER Trivandrum gets ready at Vithura in 2-3 years. They must be in a position to dismantle the setup in the present campus and re-install it at the new campus.
- Enclose pre-installation guide for the details on space, electrical power and other utilities required. Operational and maintenance manuals should also be provided.
- The vendors are requested to mention all the technical details of their model and also to supply a list of recent installations of the quoted model in India.

PART I - TECHNICAL BID:

Consisting of all Technical details alongwith commercial terms and conditions.

PART II - PRICE BID:

Showing item-wise prices for the items mentioned in the Technical Bid. The technical bid and the Price bid should be in separate sealed and superscribed covers. Both these covers are to be put in a sealed bigger cover superscribing Tender No and due date. Technical bids will be opened first and after evaluation, price bids of only the shortlisted bidders will be opened.

- 1. Tenders should be sent in sealed envelopes superscribing the relevant tender no. and the due date of opening. Only one tender should be sent in each envelope.
- 2. Late tender and Delayed Tenders will not be considered under any circumstances.
- 3. Sales Tax and /or other duties/levies where legally levies and intended to be claimed should be distinctly shown separately in the tender.
- 4. (a). Your quotation should be valid for a minimum period of 60 days from the date of opening of the Tender. Quotation with firm prices will be preferred.
 (b). Prices are required to be quoted according to the units indicated in the Invitation to Tender. When quotations are given in terms of units other than those specified in the tender form, relationship between the two sets of units must be furnished.
- 5. (a) Preference will be given to those tenders offering supplies from ready stocks and on the basis of delivery at IISER site.
