PLANT GROWTH CHAMBER

A mobile growth chamber should be specifically designed to grow Arabidopsis plant. It should provide sufficient space for growing the plant to maturity (till seeds dry) under controlled temperature, humidity and light conditions.

Construction:

The exterior cabinet should be insulated with CFC free polystyrene. The interior surface should be reflective to enhance light distribution. The chamber should accompany with proper water drainage system. Air-handling systems should ensure consistent horizontal airflow into the chamber. The three growing levels within the chamber provide maximum growing space within the smallest foot print possible. Growth chamber will be dismantled and reinstalled in new campus. Such option should be provided. Growth chamber should have following feature.

- INTELLUS® Ultra Control System for temperature and photoperiod.
- Single board solid state design
- 10 key membrane keypad with LED indicators and vacuum fluorescent display
- Real time or circadian (countdown) programming
- Programs can be run in ramping or non-ramping modes
- Multiple programs may be linked to simulate natural conditions
- 22 gauge electro-zinc plated steel exterior and interior, all seams and joints welded
- Painted with powder coat tough highly reflective white baked enamel
- Three tiers with a work area of 60 ft.²
- Two 1 1/4" Access Ports.
- Electrical requirement: Standard chamber is 120-208 VAC /3 phase / 60 Hz.
- Foam in place panel construction with high density urethane insulation.
- Cam lock panel construction for easy assemble and installation at any location without size limitations of elevators, doors and hallways.
- H9 Spray Nozzle with Some Dehumidifier via Reheat Heaters should be provided.

Lighting

The growth chamber should have a 24hours photo-period provided by 10,000 lux globe (Son-T). Option should be available to control the photoperiod. Lamps are separated by a barrier to remove waste heat before it enters into the growth volume. This in combination with lamp configurations and barriered lamp canopies should be designed to maximize light dispersion and minimize the temperature gradient across the shelf.

Shelving

Adjustable six shelves in three tiers should be vertically adjustable. These shelves should nQt have any perforation. Heat generated from lamps should not influence the temperature of subsequent shelf. Growing heights in each shelf should be approximately 55 cm and width of each shelf should be approximately 130 cm. Lower most rack should have option to accommodate small shaker.

Temperature range and safety control

Temperature range should be + 10 to +40. Adjustable high and low temperature controls, audible alarms and visual indicators should be provided. Chamber should be suitable to maintain as close as possible to 22°C [18-28°C]. The controller should shut down all the power to the chamber, and activates alarms. When the temperature returns to the normal range the system should automatically reset the temperature.

Humidity control

Based on an empty chamber with the following ambient condition of 21 °C with 50% relative humidity. Humidity range-20% to 80% is preferred.
