

- All the posts are as per the Central Government pay scales and carry allowances like Dearness Allowance, House Rent, and Transport allowance. Other benefits like Medical Reimbursement, LTC, etc. are as per the Central Government norms applicable to institute employees. The institute is to operate from a residential campus being developed at Vithura, NedumangadTaluk, Thiruvananthapuram District and the institute employees are expected to reside in the campus when quarters are constructed and made available to them.
- 2) These posts will be covered by the New Defined Contributory Pension Scheme as per the Govt. of India, Ministry of Finance Notification No.5/7/2003-ECB&PR dated 22nd December, 2003 (not applicable in case of deputation).
- 3) (a) In case of direct recruitment, the appointment will be initially on probation for prescribed period and will be confirmed based upon assessment as to successful completion of probation period failing which period of probation may be extended or the appointment may be terminated.
 - (b) In case of appointment on deputation, the initial tenure will be for 3 years which may be extended and other conditions will be regulated as per Central Government guidelines for deputations.
 - (c) In case of contractual employment the appointment will for prescribed tenure which may be extended on need basis and satisfactory/noteworthy performance. However the appointment can be terminated before the tenure after giving notice on either side.
- 4) The qualification prescribed should have been obtained from recognized universities/institutions.
- 5) Age limit and qualification will be reckoned as on the last date of receipt of application.
