GENERAL TERMS & CONDITIONS

- 1. The bidder should attach similar work completion certificate, GST registration details, PAN details or valid bidder enlistment certificate issued from IISER at the time of bidding.
- 2. Bidders are advised to go through the entire general terms and conditions of this tender carefully. The prices should be quoted in the format provided in Schedule of Quantities.
- 3. Bidders shall furnish the Earnest Money Deposit through SBI collect / Crossed Demand Draft in favour of IISER Thiruvananthapuram issued by any Nationalized Bank and endorsed by the Bank concerned at the disposal of the "IISER Thiruvanathapuram" for the work.
- 4. Quotations without EMD will be summerly rejected.
- 5. Rates quoted should be inclusive of GST and other charges if any. No extra shall be paid.
- 6. The Split Air conditioner unit shall be 2025 model complete with indoor unit, Outdoor unit and remote controller as per specifications mentioned in the BOQ. The Air conditioner unit shall be covered with guarantee/warranty from the OEM for a period of minimum one year for machine, 5 years for PCB/Controller & 10 years for Compressor. During the Guarantee / Warrantee period all defective parts should be repaired or replaced free of cost by the contractor. Equipment must be provided with the stipulated guarantee against manufacturing and functional defects and the date of warranty shall commence from the date of acceptance/ taking over in good condition.
- 7. The materials used shall be strictly as per specification and approved makes mentioned in the BOQ and tested for its quality at site by the Engineer-Incharge.
- 8. The work shall be made at IISER TVM campus, Maruthamala PO Vithura.
- 9. Payment 100% within 30 days after completing the work.
- 10. A security deposit of 5% of the awarded value of work will be recovered from the RA/Final bill and the same will be released after the completion of Defect Liability Period (DLP) of 6 months.
- 11. Rates quoted by the Contractor in item rate tender in figures shall be accurately filled in MS excel spread sheet available in IISER website along with the document, so that there is no discrepancy between the rates written in figures and words. However, if a discrepancy is found, it will be dealt as follows:-

- i. In the case of any tender where unit rate of any item/items appears unrealistic, such tender will be considered as unbalanced and in case the tenderer is unable to provide satisfactory explanation, such a tender is liable to be disqualified and rejected.
