## ANNEXUE: 2 Instructions To Bidder for Online Bid Submission

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

#### REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

#### SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

#### PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.

### SUBMISSION OF BIDS

Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.

The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.

3) Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.

4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.

5) Bidders are requested to note that they should necessarily submit their technical & financial bids in PDF format only and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.

6) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The

bidders should follow this time during bid submission.

7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.

9) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.

10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid.

This acknowledgement may be used as an entry pass for any bid opening meetings.

#### TECHNICAL SPECIFICATIONS

## Thinfilm deposition chamber with provisions for the integration with pulsed laser system

### General description:

A thinfilm deposition chamber is required for the deposition of oxide thinfilms under high temperatures and oxygen atmosphere. The chamber should have provisions that allows it to be integrated with a pulsed laser source. Additional ports and flanges are to be provided for future upgradation of equipment and accessories and process automation. The system must support a vacuum of  $10^{-7}$  Torr to atmospheric pressure. The chamber must have sufficient mechanical parts/components that facilitate uniform thinfilm deposition at high temperatures (up to  $1100^{\circ}$ C) under low mechanical noise/vibrations.

## More technical descriptions of the chamber:

- 1. Chamber: should be spherical in shape and made of stainless steel. The targets with a manipulator is to be set at the bottom port and the substrate for deposition, with heater and manipulator, is to be set at top port. The chamber should have the following additional parts /provisions.
  - i. Gate valve and it must be motorised for automated throttling.
  - ii. A separate vent valve to break the vacuum.
- iii. One port is to be dedicated for coupling with load lock chamber.
- iv. Provisions must be made for future integration of RHEED facility.
- A dedicated port should be made for the coupling with excimer laser
- vi. The chamber should have at least 3 view ports of varying sizes for comfortable viewing of the process at different angles. A shutter provision can be given for preventing the materials deposition on the viewing windows.
- vii. Appropriate ports must be provided to fit pressure gauges.
- viii. An inlet for the purge of inert/reactive gas though a mass flow controllers (MFC).
- ix. A separate port should be dedicated for insertion of a moving mask.
- 2. Moving Mask: A parallel shutter moving facility that moves linearly just below the sample is necessary. The distance between the moving mask and substrate can be 5 to 10 mm. The mask movement arrangement can be a linear actuator with linear encoder such that the positioning accuracy is 5 micron or better. Provisions should be made for automation in future.
- 3. Heater flange and manipulator: The heater flange consisting of heating stage and thermocouple and power supply feedthroughs should allow 1 or 2 inch substrate clamping. Provisions should be made for substrate rotation (typically 0-10 rpm) using a stepper motor and also a translational (z) motion so that the substrate height with reference to horizontal moving mask position and the target height can be varied.
- 4. Heating stage: should support at least 1" diameter substrate. The maximum reachable temperature should be at least 900°C. The heating and cooling processes should be controlled through an Eurotherm PID controller.

- 5. Target: A total of 6 metallic stubs, should be provided at the bottom port of the chamber for individual target placement. The design must allow a few mm target height adjustment. Typical target disc size is 25 mm diameter and 8 mm thick. The mechanical motion must allow raster and rotation (~30 rpm) of target and the target carrousel speed should be 30 rpm. A combination of appropriate feedthroughs and stepper motors should be used to ensure a smooth and precise motion.
- **6. Mass flow controller:** One digital MFC, build for standard gases, to control up to 100 sccm (preferably MKS) should be provided with necessary gas line fittings.
- 7. Optical parts: Optical window ports with suitable UV glass discs, mirrors and other mechanical supports, that can be aligned such that laser pulse hit the target at the desired location, should be supplied.
- 8. Load lock chamber: A design that is compatible to the main deposition chamber, which allows sample transfer without breaking the vacuum of the main chamber should be provided. The load lock chamber should have provisions for sample placement, view and sample transfer. It should be isolated from the main chamber through a gate valve however, the sample loading /unloading glass window/door may be a o-ring based. The load-lock chamber can be separately pump down by a suitable turbo molecular pump though a gate valve.
- 9. Support and Frames: The main chamber should be compatible to turbo molecular pumps, backed by dry pumps, supplied by standard commercial vendors, pressure gauges, cables and other accessories. A metal frame that can house the main and load lock chambers and all pumping systems and accessories without obstructing/hindering the deposition process is necessary.
- 10. Spares: Additional heating stage parts, optical window ports, lenses, mirrors, flanges, metal gaskets, orings, cables and other materials for running and periodic maintenance should be supplied.
- 11. Water chiller: To cool heater electrodes
- 12. PC based process automation: Automation of mask movement, target rotation, carousel and sweep, temperature program, pumps, vacuum gauges, valves, pressure and mass flow control may be done in future. Therefore, the system design must accommodate all these features.
- 13. Documents and Manuals: A detailed sketch of design, individual components/parts with supporting technical details must be furnished. In addition, the manual of the components (both hard and soft copy) of the chamber and related software must be supplied during system delivery.
- **14. Installation:** The supplier must undertake the responsibility of successful installation of entire system at IISER TVM.
- 15. Warranty: The supplier should provide at least one year warranty from the date of installation or acceptance. An additional quote for 2 years extended warranty / AMC is necessary.
- 16. Miscellaneous: The system must be compatible to the Indian electrical power standard and supplier must clearly mention about the electrical requirements, space requirements and gas connections etc.
- 17. Additional requirements: 1. PLD system manufacturing experience and a complete list of PLD systems installations. 2. Contact details of at least 5 PLD system customers.
