3. Tender documents can be downloaded from website **Central Public Procurement (CPP) Portal <https://eprocure.gov.in/eprocure/app> or Institute website www.iisertvm.ac.in and bid is to be submitted online only through the E-procurement portal up to the last date and time of submission of tender.**
4. Downloading of tender documents alone will not make a tenderer eligible for participating in the bidding. The documents uploaded by the tenderers will be subjected to verification subsequently by Department. If found not meeting the requirement, such offers will be rejected.
5. Tenders should be accompanied with Earnest Money Deposit for value specified in Para 1 above, in the form of Deposit at Call Receipt / Term Deposit Receipt / SBI collect/ Demand Draft of any Scheduled Bank issued in favour of **IISER THIRUVANANTHAPURAM** (or) in the form of Bank guarantee issued by a scheduled bank. Earnest Money Deposit shall be valid for 180 days from the due date of receipt of tenders. In case EMD in the form of DD is

furnished, the same will be encashed immediately on opening of tenders and refund of EMD for unsuccessful tenderers will be made through cheque / electronically by the Department.

6. Tenders will be opened through CPP portal at the **Project Engineering Division, Indian Institute of Science Education and Research, Thiruvananthapuram** situated in Vithura on the stipulated date and time specified in Para 1 above.
7. Original instrument of EMD shall be submitted to the Project Engineering Division, IISER, Thiruvananthapuram on or before due date and time of opening of tender. If valid EMD is not received on or before due date and time of opening of tender, the tender offer shall be summarily rejected.
8. On the due date of opening, the Technical & Commercial bid of those tenderers who furnished valid EMD only will be opened. On opening of Technical & commercial bid, further detailed scrutiny / evaluation will be carried out. During the evaluation of techno-commercial bids, the documents furnished by the tenderers will be scrutinized in detail. Any tender, found as not fulfilling the eligibility criteria will be rejected at this stage and such offers will not be considered for further processing. The price bid of only those tenderers who have been qualified during the scrutiny and technical evaluation will be opened separately on a specified date (with due intimation to the qualified bidders) and further processed, as per tender procedure/ stipulations.
9. The contractor, whose offer is accepted, will be required to furnish performance guarantee of **5% (Five Percent)** of the tendered amount within 15 days from the date of issue of letter of intent/work order. This guarantee shall be in the form of Deposit at Call receipt/Term Deposit Receipt of any Scheduled Bank issued in favour of **IISER Thiruvananthapuram** (or) in the form of Bank guarantee issued by a scheduled bank in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period specified including the extended period if any, the Earnest Money deposited by the contractor will be forfeited and letter of intent/work order cancelled automatically without any notice to the contractor. The Earnest Money deposited along with tender shall be refunded only after receiving the aforesaid performance guarantee.
10. Intending tenderers may inspect the site before submitting the tenders.
11. The tender accepting authority on behalf of **Director, IISER Thiruvananthapuram** is

not bound to accept the lowest or any other tender and reserves the authority to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.

12. The tender accepting authority on behalf of **Director, IISER Thiruvananthapuram** also reserves the right to alter the scope/or reduce quantum of work before issue of work order and the tenderer shall not have any claim what so ever on this account.
13. The tender accepting authority on behalf of **Director, IISER Thiruvananthapuram** reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
14. Canvassing directly or indirectly, in connection with tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
15. The tender accepting authority reserves the option to give preferences to the offers in accordance with the policies of the Institute /Government from time to time.
16. The contractor shall not be permitted to tender for works responsible for award and execution of contracts for which his/her near relative is working. He/she shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any IISER Officials. Any breach of this condition by the contractor would render him liable for rejection of tender or cancellation of contract.
17. The tender should be valid for minimum period of 120 days from the due date of receipt of the tender specified in Para 1 above. If any tenderer withdraws the offer within the validity period or makes any modifications in the terms and conditions of the tender which are not acceptable to the Institute, the Institute shall without prejudice to any other right or remedy, be at liberty to forfeit 50% (Fifty Percent) of the Earnest Money Deposit absolutely. Further, the tenderer shall not be allowed to participate in the retendering process of the work.
18. The rates should be inclusive of GST as applicable and levies payable under respective statutes. Any claim on account of this will not be admissible. Hence, tenderers are advised to quote their rates inclusive of GST, levies, transportation charges, freight charges, octroi, loading unloading charges etc Nothing extra shall be paid.
19. The Institute will fix only one agency i.e. the main contractor for the work who will be responsible for execution of entire work.
20. On concluding the tender, an agreement shall be drawn with the successful tenderer
