## Buyer Added Bid Specific Additional Terms and Conditions

1. Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods
2. Installation, Commissioning, Testing, Configuration, Training (if any - which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.
3. IT equipment shall be IPv6 ready from day one.
4. **OPTIONAL SITE VISIT:**
  1. The Bidder is advised to visit and examine the installation site and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder. At own cost
  2. The Bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.
  3. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.

5. Buyer Added text based ATC clauses

1. The solution must ensure wireless signal strength of at least -65dBm inside all the hostel rooms after closing doors and windows. Wireless heat map depicting the signal coverage inside rooms for all the floors of both the hostels should be submitted along with the offer
2. The estimated number of access points is mentioned in the BOQ. The bidder is free to quote the required number of access points for optimum coverage
3. The bidder must have supplied, installed and commissioned a wireless network with a minimum value of Rs.30/- lakhs or two wireless networks with a minimum Rs.15/- lakhs each at any Government Department or Government institutions or reputed private institutions in the last three years. Documentary proof of Purchase / work order to be enclosed with performance certificate from the Government Department OR Government institutions or Reputed private institution
4. Statutory documents/ registration to be enclosed PAN, GST etc.
5. The bidder must have cumulative financial turnover of min Rs.1Cr in the last 3 financial years and shall have not incurred any losses in any of the financial years. A self-certification may be provided with documentary proof.
6. Warranty: Minimum 3 years from the date of Installation, commissioning and performance test check for all the components mentioned in the BOQ. The bidder shall provide a declaration in this regard.
7. Declaration to be provided mentioning the repair / replacement would be made within 5 working days from the date of report of issue.
8. Optional: AMC: Minimum 3 years from the completion of warranty period
9. Payment: (i) 80% against delivery of all components and (ii) 20% after A) Installation, B) performance test check report, C) submission of bank guarantee 3% covering the warranty period + 3 months
10. Site Visit: The prospective bidder may visit the site for inspection at their own expense with prior approval of the Institute.

6. Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

## Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid.
